Focus on companies with pricing power, and large economies of scale

Dear Investor,

PERFORMANCE RECAP

Our portfolio has delivered a -3.3% return vs -5.2% return for the Nifty 500 during June 2022, thereby outperforming by 190 bps. Our overweight stance on Industrials, Consumer, and Power sector aided our performance. This was partially negated by our overweight stance in the Textiles Sector. The stocks which outperformed were ITC, Timken India, Phoenix Mills, KEI Industries and Bharat Electronics. The stocks which dragged our performance were Vardhaman Textiles, and Astral Poly.

On a one-year basis, our portfolio delivered a return of 5.1% vs -0.6% for the Nifty 500, outperforming the benchmark by 574 bps. The changes in the portfolio (during Sept-Oct '21 period) with a tilt towards a Growth at Reasonable Prices (GARP) approach has led to an improvement in the overall performance as against a pure Value Approach earlier. The portfolio outperformed the index mostly due to stock selection in Specialty Chemicals and Consumer-oriented sector as well as an overweight position in Industrials and an underweight stance in the Financial sector. Two of our top holdings i.e. Timken India and Phoenix Mills, contributed meaningfully to our outperformance, thereby reflecting the high conviction calls in the portfolio.

INVESTMENT PROCESS

We invest in structurally strong companies that are termed as good quality companies. A good quality company is a company that has reached a minimum scale in terms of revenue, has gone through at least one downcycle and emerged as a stronger company, has a consistency in cash flows and higher return on capital employed over the last 10 years. The second aspect has been to always own companies which are market leaders in a particular domain. We have, over a period of time, seen that market leaders generally tend to come back stronger with higher market share after the downturn, as weaker players usually exit in the downturn.

All stocks which have a large weightage in the portfolio currently - SBI, Timken, Bharat Electronics, Asian Paints, VST Tillers & Tractors, Phoenix Mills, etc. were bought keeping above mentioned thought process in mind.

PORTFOLIO OUTLOOK

Key argument for a sharp downside in equity valuations is being driven by the extreme fear of a structurally rising inflation and bond yields, thereby resulting in an environment of significant underperformance for equities. However, commodity prices have been coming off highs. With India being a net energy importer (energy imports account for 4% of GDP by value) as well as reliance on metals/other commodities on imports being on the higher side, it bodes well for consumption industries. After the initial shock, we believe, across the board decline in global commodity prices along with lower freight rates weaken the structural inflation argument.

Additionally, high frequency growth indicators for Q1FY23 are robust for India so far:

- Strong manufacturing and services: Average PMI-Manufacturing at 54.4 and PMI-services at 58.4 for Q1FY23 (Apr-Jun'22) are robust. Export growth at 16.77% YoY for Jun'22 and GST collections at Rs 1.45 trn for Jun'22 are also robust.
- Core sector and credit growth improving: Core sector growth in May'22 was 18.1% YoY and non-food credit growth in Jun'22 was 12.6% YoY.
- Southwest monsoon has covered the entire country about a week earlier than the normal date of July 8th, as per the IMD.

During Q1FY23 results, the key focus would be on management commentary on overall demand environment in the backdrop of elevated inflation, price & interest rate hikes and slowing global growth. Margin and supply side pressures would be other key monitor-ables.

We are focusing on companies with visibility of earnings growth with higher certainty equivalent factor and not trading at very high valuations. Companies with strong brands, pricing power, and larger economies of scale continue to be a part of our portfolio. We continue to be positive on Industrials (including Capital Goods) on account of economic recovery. In addition, we are bullish on the Real Estate sector given the consolidation on the supply side and improvement in affordability on the demand side.

We continue to believe that Investors with a 3-5-year view would benefit from investing in the current scenario.
