Quality Portfolio at Reasonable Valuations

Dear Investor,

PERFORMANCE RECAP

Our portfolio delivered a return of 5.99% vs a 4.10% return for Nifty 50 TRI during the month of April'23, thereby outperforming by ~190bps. Our overweight stance on Autos, Chemicals, Pharma and Industrials aided our performance for the month. The stocks which outperformed were Eicher Motors, PI Industries, Syngene International and Astral Ltd.

On a one-year basis, our portfolio delivered a return of 9.98% vs a 6.89% return for Nifty 50 TRI, outperforming the benchmark by 310 bps. The changes in the portfolio (during Sept-Nov'21 period) with a tilt towards Growth at Reasonable Prices (GARP) approach has led to an improvement in the overall performance.

The portfolio outperformed the index due to our overweight position in Industrials, Building Materials and Underweight stance in the Information Technology (IT) sector. Four of our top holdings i.e. Timken India, Phoenix Mills, SBI, and Cummins India contributed meaningfully to our outperformance, thereby, reflecting the high conviction calls in the portfolio. VST Tillers & Tractors and Infosys were the laggards in our portfolio.

INVESTMENT PROCESS

We invest in structurally strong companies, that are termed as good quality companies. A good quality company is a company that has reached a minimum scale in terms of revenue, has gone through at least one downcycle and emerged as a stronger company, has a consistency in cash flows and higher return on capital employed over the last 10 years. Second aspect has been to always own companies which are market leaders in a particular domain. We have over a period of time seen that market leaders generally tend to come back stronger with higher market share after the downturn as weaker players usually exit in the downturn.

ADDITION TO THE PORTFOLIO

Syngene International : Syngene, the largest Indian Contract Research Organisation (CRO), has over the years established strong credentials in the Discovery and Development verticals. Recently, the company has forayed into commercial manufacturing for innovator customers (CMO segment) with a small molecule API facility in Mangalore and a biologics manufacturing capacity in Bangalore. We believe the innovator CMO space is highly complementary to the CRO space and Syngene's two-decade experience & track record of working with innovators positions the company for scaling up the CMO business.

PORTFOLIO OUTLOOK

Indian markets are trading slightly above long term averages (and closer to +1SD). However, earnings growth are expected to be in the range of 13%-15% p.a. for the next two years and in light of growth valuations are not overtly excessive. The vagaries of weather, normalcy of monsoon and possibility of El-Nino is there which can impact sentiments in the near term, however, we do not expect it to impact longer term growth prospects. However, in the event of the above keeping food and hence over inflation levels elevated, it can impact consumption and interest rates in the economy and hence become a key monitorable.

Clearly we see India as a standout proposition in the global economy. With focus on continuous asset creation, benign policy environment, prudent fiscal management and improved global standing augurs well for the economic growth of the country. Further, lower leverage by India Inc and improved Balance sheet of the financial system provides fodder for growth as demand levels in the economy move up in tandem with income levels. While global events can be a challenge, we reckon India is not only well placed to weather these challenges, but also benefit from the same in the longer run. We see consumption and manufacturing spearheading India's growth led by demographics, higher per capita income and penetration with exports remaining a longer term but invaluable growth driver.

We are positive on Industrials, Autos and Building Materials. We have increased our weight in Information Technology (IT) sector and are now Equal weight on the sector vs Underweight earlier. We continue to believe that investors with a 3 to 5-year view would benefit from investing in the current scenario.
